- 1. ENTRY FEE:** Entry into these awards is free.
- 2. CONDITIONS OF ENTRY:** The 'Artworks!' Art Awards 2009 are open to any adult resident of Queensland who has a proven disability. Entrants must have proof of eligibility such as a DSP or a Treating Doctors Report. Entrants must be 18 - 64 years old to enter the awards.
- 3. HOW TO ENTER:** Entry forms can be downloaded from our Website. Go to www.kithandkin.com.au. Then in the links column click on downloads to access entry forms.
 - MAIL an Entry form, A5 photo of artwork and a normal size photo of self with a short personal profile to: 'ArtWorks!' Kith and Kin Association Limited P.O. Box 6 Wulguru, QLD 4811
 - Entries forms must be received by 4pm, 7th August 2009. No late entries will be accepted.
 - First selection process will be judged on the 12th August 2009.
 - All entries selected for final judging will be notified and asked to send work.

Please note it is important to submit the photograph of your artwork, as a Selection Panel of Judges will judge this initial entry. Photos of Artists and Profile will be submitted into catalogue along with photo of artwork.

4. ENTRY CRITERIA: Artists may enter 4 works in total with a maximum of 2 works in any one section.

5. SIZE AND FRAMING:

- All works must be wired and fitted with "D" rings ready for hanging.
- Canvases must not exceed 60cm x 90cm unframed.
- 3D Wall Art must not exceed 60 x 90cm.
- All Works on paper must be framed.

Any artwork not correctly presented may be refused.

6. IDENTIFICATION: All selected entries must have label attached to back of work displaying Artist's name, Section, Title of Work, Medium used and Sale Price if applicable.

7. STANDARDS: The Awards Committee relies on the integrity of all competitors. Entries must be the artist's original work, executed during the past year and not previously entered in any other awards. Reproductions/Copies of other Artists work are not acceptable.

8. CATALOGUE: Information will be taken from entry forms and no changes will be made. You must have a title for your entry at time of lodgement. We request that you keep your titles to a maximum of five words.

- 9. DELIVERING OF ART WORKS:** Works selected must be received at Kith and Kin, 711 Flinders St., Townsville by 4pm Friday 28th August 2009, for categorising before hanging.
- 10. JUDGING:** Judging will be conducted by a prominent artist specialising in each section's medium. Final judging will be on the 8th September. The judge's decision will be final and binding and no correspondence will be entered into. All awards will be allocated at the judge's discretion (eg. There may be insufficient entries).
- 11. AWARDS:** Monetary prizes and trophies will be awarded for 1st, 2nd and 3rd prize in section 1 – 3. The Xstrata Award for the overall winner of the exhibition will receive a monetary prize with a perpetual trophy awarded. The Encouragement Award will receive a framing voucher from Townsville Art and Framing.
- 12. EXHIBITION OF WORKS:** An Exhibition of works selected for final judging will be held on the 6th – 20th September 2009 at Umbrella Studio of Contemporary Art, Townsville. Depending on hanging space and number of entries any excess of work will be hung at the Aitkenvale Library, Townsville during the Exhibition. However all works will be judged.
- 13. PRESENTATION CEREMONY:** Presentations will be awarded at the Opening Launch of the Exhibition on Sunday 13th September 2009 starting at 10am at Umbrella Studios. All entrants, families and friends are welcome to attend. Light refreshments will be available.
- 14. SALE OF ARTWORK:** Work for sale is at the discretion of the Artist. All monies from sale of work will go to the Artist.
- 15. COSTS:** All freight costs, forward and return, and insurance of entries will be borne by the competitor. Packing must be of a quality to allow for it's reuse for return of unsold work. A prepaid freight docket or freight account number must accompany the artwork. Kith and Kin take no responsibility for Artist's work and it is exhibited at their own risk.
- 16. COLLECTION OF ENTRIES:** Artwork must be collected from Umbrella Studio during demounting hours. Demounting on Sunday 20th September 2009 at 9am – 1pm. No responsibility will be taken for works not collected.
